**Subject: Resolution No 18-21 Mower purchase Park Recreation –
Rough mower for Wildwood Golf Course**

Recommendation: Approve purchase of John Deere 9009A from Van-Wall Equipment, Inc. for \$30,000, using capital equipment reserve funds.

Background Summary:

Attached are four quotes for used rough mowers to replace the aging rough-cut mower currently being used at Wildwood Golf Course.

The existing roughcut mower is a 2002 Jacobson with 4,000+ hours and little value or life left in it. Parts hard to find and Street Dept. Mech can't fix anymore.

The three quotes listed include:

- JD 9009A – 2018 - Diesel– 850 hours - \$33,500 – J.W. Turf, Inc.
- **JD 9009A – 2018 - Diesel – 770 hours - \$30,000 – Van-Wall Equipment**
- Jacobsen HR600 – 2018 - Diesel– 1600 hours - \$30,000 – Turf Werks
- Jacobsen AR522 – 2017- Diesel – 1300 hours - \$19,000 – Turf Werks

Tyler Mitchell is recommending the purchase of the 2018 JD 9009A mower from Van-Wall Equipment total cost of \$30,000.

Funds to cover the purchase of this piece of equipment would be transferred in from the Park & Recreation Capital Equipment reserve fund.
