Subject: Consider request for street closure for moving the depot

Background Summary:

The American Passenger Train History Museum is ready to move the former Canadian Pacific Railroad depot building from its location next to the CP railroad tracks to the new museum location near 11th Avenue and North Grand Avenue. The move will require the closure of 11th Avenue from North Grand Avenue to D Street.

The move is scheduled to begin on Wednesday October 6th. The depot building will first be moved to a location near the southeast corner of the former Simply Essentials property. On Friday, October 8th, the building will be moved across the Canadian National Railroad tracks and along 11th Avenue close to the new foundation for the railroad museum. The building will remain within the 11th Avenue right-of-way until Monday, October 11th. On October 11th, the building will be moved from the right-of-way onto the new foundation.

The street closure request form has been submitted by Robert Moen with the museum and authorization granted by Chief Anderson. We recommend the Council approve the request to close 11th Avenue from Friday, October 8th, through Monday, October 11th.

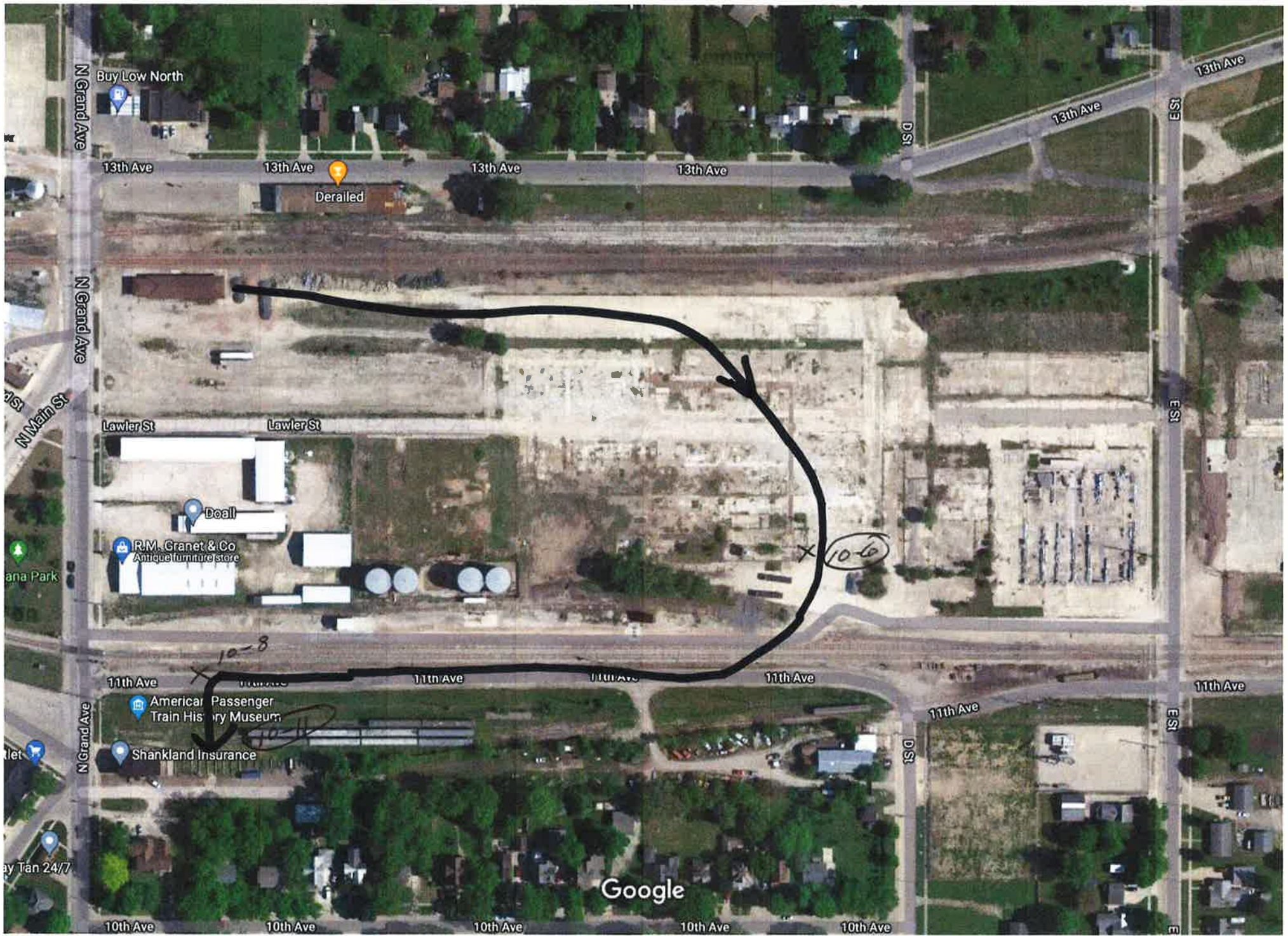
