**Subject: Consider Resolution 133-21 approving a change to the traffic code regarding no parking on North Grand Avenue**

---

**Background Summary:**

The City's Traffic Code has several listings regarding parking restrictions around the former middle school building. On the east side of North Grand Avenue between Fifth and Sixth Avenues, there is no parking from 7:30 to 8:30 in the mornings and 2:30 to 3:30 in the afternoons Monday through Friday. Parking is banned from 8:00 AM to 4:00 PM Monday through Friday on the north side of Fifth Avenue between B and C Streets and on the south side of Sixth Avenue between North Grand and C Street.

Congestion and conflicts created by school traffic were the main reasons for the parking restrictions. Since the school is no longer at this location and the reasons for the no parking zones have been eliminated, we are proposing to amend the Traffic Code to remove these parking restrictions.

We recommend approval of Resolution Number 133-21.

WHEREAS, it is in the best interests of the citizens of Charles City, Iowa that the no parking area on the east side of the building at 500 N. Grand be deleted from the traffic code .

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charles City, Iowa, meeting in regular session on this 15<sup>th</sup> day of November, 2021, that the official Traffic Control listing is amended by the following deletions:

**NO PARKING 7:30A.M. TO 8:30A.M. AND 2:30P.M. to 3:30P.M., EXCEPT SATURDAY AND SUNDAY**

3. **NORTH GRAND AVENUE**, on the east side from 5<sup>th</sup> Avenue to 6<sup>th</sup> Avenue.

**NO PARKING 8:00A.M. TO 4:00 P.M., EXCEPT SATURDAY AND SUNDAY**

1. **FIFTH AVENUE**, on the north side, from “C” street to “B” street
2. **SIXTH AVENUE**, on the south side, from Grand Avenue to “C” Street
