RAGBRAI parking lot and street closures

The parking lots between North Main and North Jackson Streets in the 100 and 200 blocks will close either day prior or possibly 2 days before the event for set up.

The parking lot between N Main St and City Drive and will close the day prior to RAGBRAI. This also includes the parking lot south of City Hall. Part of this lot will be closed for 2-3 weeks prior the event to facilitate a mobile tower unit for US Cellular. They are coming at the request of the CCPD.

The streets closures will be one day prior around Central Park and in the 200 block of N Jackson Street to facilitate set up of equipment.

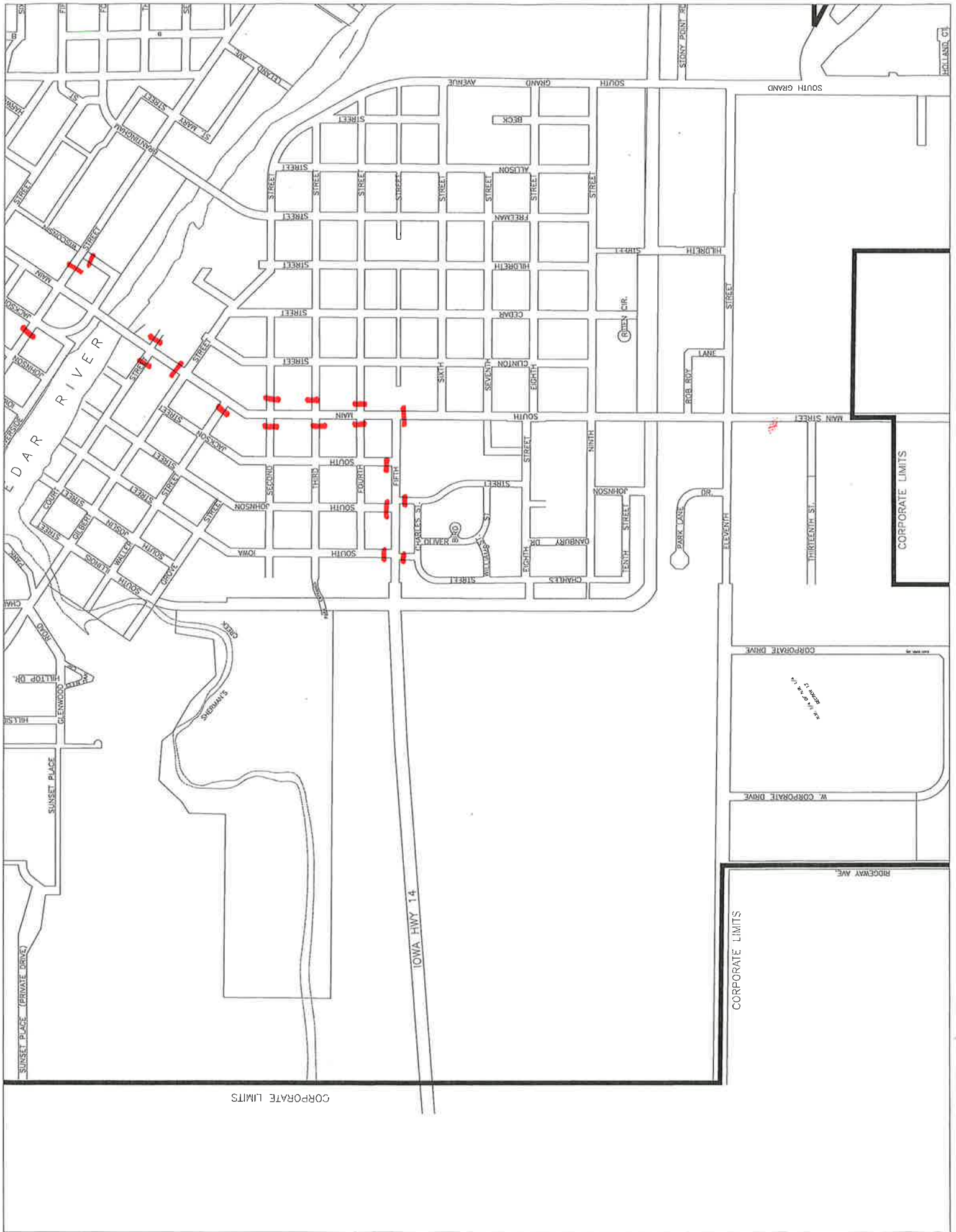
The street closures of North Main, Riverside, Clark, and further out on Kelly and Blunt will be the night prior to the event. Also City Dr from the driveway of the CC Press to the south.

The route into the downtown including all side streets intersecting Highway 14 and S Main Street will be closed in the early morning hours of July 28. They will be re-opened the evening of the 28th at around 6-8 pm.

South Main Street at Gilbert Street to the north of the intersection will be closed in the early morning hours of the 28th along with the intersection of S Main St and Court St. These will remain closed until the early morning hours of the 29th.

No citizen vehicle access will be permitted in the downtown area including the above parking lots during the event.
